In order to keep us from losing another show date, the board decided to keep the Easter weekend show on the calendar, but change from Sat-Sun. to a Fri-Sat. show, so that's the reason for our April show dates being April 19 and 20. The class schedule will remain the same, except that there will be no Youth class on Friday, April 19, due to NCHA rules regarding Youth classes during the week. Also, the AQHA classes will be held on Saturday, April 20 only, as there is an AQHA show in Whitesboro, TX on Friday, April 19, so AQHA will not allow our show. Buckle class will be on Sat. also.
