It was great to be back in the cutting pen for our August 1st and 2nd show. Thank you so much to all who attended, and for your patience and understanding with the "extra rules and regulations" we had to follow this time.

A lot of changes happened to our planned show schedule this year. Due to the COVID shutdowns, we lost our April and May shows in Amarillo, but New Mexico CHA generously allowed us to sanction their Memorial Day Circuit in Farwell, TX to replace the lost show days.

We are excited about adding a new venue to our show schedule. We are producing a 3-day show in Lubbock, TX on September 4, 5, and 6 at the Texas Tech Equestrian Center. There will be Futurity and Derby classes plus all weekend classes, including the Youth, all 3 days. PLEASE turn your stall reservations in to Lee Ann (620-664-7230) by Monday, August 31, 2020, and also the number of bags of shavings per stall you will need. We need to have the stalls assigned and shavings put out before people arrive at the show grounds.

TX Animal Health Commission rules will also be in effect at this show, so that means 12-month Coggins for in-state horses and 12-month Coggins + 30-day health papers for out-of-state horses. If coming from a state with a current VSV outbreak, the health papers need to be current within 14 days. Coggins and health papers will need to be presented to show secretary.

- **CHANGE TO NCHA STANDING RULE 14.b. "In three-horse classes with \$300 added or more, the payout will be made from the added money only. The 8% fee will be remitted to NCHA from the entry fees collected. The show will retain the remaining portion of the entry fees. Four horse or more classes will use the standard NCHA payout. This stipulation applies to all weekend and weekend LAE shows."**
